Participant agrees that in consideration of my dog and I being permitted to enter, use, and enjoy any of the property and facilities of (Historic Santa Margarita Ranch) (herein known as "SMR") including but not limited to freeholds, rights of way, licenses and leases (together, the "Premises"), whether owned, managed, or controlled by SMR, or any owner of private property (collectively "Released Parties") for which SMR has an agreement to use part or all of the property for Paso Robles Pioneer Day ("PDC") and Rossi Foundation ("RF") equipment show, including but not limited to PDC, RF, Best of the West ("BOTW"), Robin L. Rossi, Trustee of the Robin L. Rossi Living Trust ("Trust"), Stephen and Michelle Rossi Revocable Trust ("SM"), Luke Roger Rossi Revocable Trust ("LR"), Tom Madden ("TM"), Peter Bloom ("PB"), Once Upon a Time, L.P. ("OUT") and ACMOC (together, "Releasees");

1. I hereby release, waive and discharge Releasees and their owners, officers directors, employees, contractors, and agents, from all liability to the Participant, or Participant's Dog, for any and all loss or damage and any claim or damages in any way resulting from the presence of Participant or Dog, including injury of the Participant or Dog, death of the Participant or Dog, and participant or Dog becoming prey of local wild animals, whether caused by the negligence of Release, or otherwise resulting from permission to enter, use and enjoy any of the premises.
2. Participant hereby agrees to obey the SMR Policy set forth on the reverse side of this Release.
3. Participant assumes full responsibility for the risk of bodily injury, death or property damage due to the negligence of Releasees, or otherwise while in or upon the Premises, while maintaining officiating, working of for any purpose participating in said activity.
4. Participant warrants that no promise or inducement has been offered or made except as set forth in this release, that this release is executed without reliance on any statement or representation by Releasees, or by any agents of Releasees, concerning the nature and extent of the injuries and damages or either of them or the legal liability for the same Participant is of legal age, is legally competent to execute this release and is legally competent to accept the full responsibility for the same.
5. Participant agrees that this release, waiver, and indemnity agreement is intended to be a broad and inclusive as permitted by the laws of the State of California, and that if any portion of this agreement is held invalid, it is agreed that the balance shall; notwithstanding, continue in full legal force and effect. This release contains the entire agreement between the parties to this release and the terms of this release are contractual and not a mere recital.
6. Participant agrees to make no claim against Releasees for any claim, loss, damage, or injury which this release purports to cover.

7. Participant agrees that all obligations assumed and promises made by Participant under this release shall be binding on my heirs, and the executors and administrators of my estate. Participant further instructs said heirs, administrators, and executors to honor this release and make no claim against Releasees for any claim, loss damage, or injury which this release purports to cover.

PDC/RF/ Historic Santa Margarita Ranch Dog Policy

PDC, RF, SMR, BOTW, TM, PB, Trust, SM, LR, OUT & ACMOC agree that nice dogs are allowed on SMR property, and problem dogs are not!

PDC, RF, SMR, BOTW, TM, PB, Trust, SM, LR, OUT & ACMOC, have agreed to implement the following Dog Policy, May 24-26, 2019

1. Dog owners will sign a Dog Release before dogs get out of the vehicle that brought them. The Dog Release will cover these points:

- A.-- Owners assume all liability for any incident resulting from their pet being on the property.
- B.-- Owners agree not to sue PDC, RF, SMR, BOTW, TM, PB, Trust, SM, LR, OUT & ACMOC, or other participants over dog related issues.
- C.-- Owners understand that dogs may be prey of local wild animals.
- D.-- Owners agree to obey Dog Policy, as stated on page one (1) of the Dog Policy.
- E.-- Dogs will be vaccinated for rabies.

2. Dogs must be on a leash, held by an adult, when outside their motor home or trailer, or other vehicle at all times or confined to a container.

3. Dogs will NOT BE ALLOWED in the show area. They will only be allowed in the RV camping area, or parking areas for transporting vehicles.

4. Dog owners, MUST CLEAN UP THEIR DOG'S DROPPINGS (POOP).

5. Dog's must not be annoying (BARKING) to your neighbors. If they cause a problem, you may be asked to remove them from the SMR property.

All changes to this Dog Policy will be jointly agreed by PDC, RF, SMR, BOTW, TM, PB, Trust, SM, LR, OUT & ACMOC.
