

Regulations pertaining to Personal Transportation Vehicles

“Tractors will not be considered PTV”

- All **Personal Transportation Vehicles (PTV)** must be registered
And a **proof of insurance** on each vehicle listed on application form.

Exemptions:

- * Electric Power carts used by a handicapped person.
- * Tractors, Trucks, Lawn and Garden Equipment built prior to 1980 and displayed in the exhibitor area for the duration of the show.
- * Required display area is _____.

If you intend to operate any vehicle as a PTV on the Historic Santa Margarita Ranch, you must send this form in with your exhibitor agreement or bring this form when you arrive at the entrance gate in order to operate on the grounds.

Permit stickers will be held and can be picked up onsite upon arrival to grounds.

If your PTV is not displayed in the designated area you will need a permit.

Exhibitors who have a specific need or requirement to operate a PTV in order to maintain or support their exhibit may check with the safety officer special exemption.

A speed limit of 5 miles mph will be observed while driving on the grounds.

Any one wishing to use a PTV must be an ACMOC or EDGE&TA member and hold a current license to operate a motor vehicle (16 yrs and older).

Vehicles may only carry passengers indicated by the manufacturer.

Those wanting to register a PTV must include a copy of (auto policy, home owners policy, or ranch policy) naming each PTV and list the limits of the insurance carrier. Check with your insurance carrier prior to attending this show in June.

PTV's not conforming to the above guidelines may have their permit revoked and be banned from use on the Ranch.
